Infection control has always been a top priority, and you may have noticed this during your visits to our office. We have established infection control processes that have been in place for the safety and comfort of our patients and for our own protection as well. We have added some safety controls on top of our normal procedures for added precaution and want to make sure you know what to expect as you return to see us.

ON THE DAY OF YOUR APPOINTMENT GO TO WWW.PJORTHODONTICS.COM AND CLICK ON THE LINK "PATIENT FORMS". SCROLL DOWN AND CLICK ON RED LINK "SUPPLEMENTAL INFORMED CONSENT AND HEALTH QUESTIONNAIRE. AFTER READING, CHECK "I CONSENT TO TREATMENT", ENTER PATIENT NAME, TODAY'S DATE, AND SIGN (FINGER WORKS ON YOUR PHONE☺). SCROLL DOWN AND COMPLETE THE HEALTH QUESTIONNAIRE, CHECK THE "I UNDERSTAND BOX", SIGN AND **SUBMIT.**

THIS MUST BE DONE TO BE SEEN FOR YOUR APPOINTMENT☺

- Please **brush your teeth before arriving** at the office. The brushing station needs to remain closed at this time.
- Patients are asked to **wear a mask to the office** or will be provided a mask upon arrival. Patient masks will be worn other than during their appointment.
- We have hand sanitizer that we will ask all patients to use upon entry.
- A **Wellness Screening will be performed** upon entry to our office and your temperature will be taken
- **Social distancing, whenever and possible**, will be practiced; this includes limited treatment area seating and the closure of our waiting room.
- We ask that **only the patient come in for their appointment**. If a parent would like to escort their child, then only one parent will be allowed and will also be subject to the full check-in protocol, including wearing a mask.
